- All necessary show materials will be mailed to accepted vendor's provided postal address 2 weeks prior to show date.
- **REFUNDS WILL NOT BE GIVEN IN THE EVENT OF VENDOR CANCELLATION ON OR AFTER OCTOBER 18, 2019.**
- No show with no notification may be denied space at future events.
- Convention Center vendors must participate in all three days (Friday, Saturday and Sunday).

Conditions of Contract. Please read carefully!

Miscellaneous Information:

- **This is a juried show. Products deemed by the Rehoboth Beach-Dewey Beach Chamber of Commerce (RBDBCC) not to be in the best interest of the show will not be accepted. A limited number of vendors with the similar product may be accepted at the discretion of RBDBCC, considerations for acceptance include: Competition with a vendor area storefront and Competition with a Downtown storefront located outside of the vendor area.**
- RBDBCC members are not guaranteed acceptance, but are given the first opportunity to apply for booth space and a discount.
- Vendors who have participated in prior festivals are NOT guaranteed acceptance or the same space location as previous year.
- Limit 1 (one) artist per 10' x 10' vendor space (no sharing of single space).
- Show will consist of approximately 25-35 vendors.
- Only items pre-approved by RBDBCC are permitted for sale/ display at booth space. No knives, guns, other weapons or explosives are permitted. No commercial clothing, jewelry, etc. sales permitted; only handmade items.
- **RBDBCC has the authority to request the removal of unapproved merchandise from a vendor space at any point in time during the show.**
- When possible, Heritage/Artisan Crafters (i.e. Broom Maker, Weavers, Carvers, etc.) are asked to demonstrate their craft during the show.

Vendor Space Information:

- 10' x 10' spaces sold first. Any remaining space will be sold at a price per square foot rate.
- Vendors must provide their own tables and chairs. All tables must be covered and skirted.
- Tents/canopies not permitted.
- Electricity cannot be guaranteed. Water access is NOT available on-site.
- Vendors are responsible for all licenses that may be required for the sale of their product.
- All vendors are responsible for the cleaning of their space at the end of the weekend/show.

Vendor Set-Up and Breakdown Information:

- Chamber staff will be on-site during show hours. Convention Center will be closed while not in use.
- The Chamber is not responsible for lost or stolen items.
- Vendors must remain at their booth during posted show hours. No early breakdown permitted.
- Failure to abide by set-up and breakdown instructions may affect acceptance in future shows.
