# FROM THE CITY OF REHOBOTH BEACH

In September 2017, the Mayor and Board of Commissioners established an advisory committee to study City of Rehoboth Beach Code issues. The Law Oversight Committee will be composed of five volunteer citizens who live, work, own property or operate a business in Rehoboth Beach and, like the rest of the community, are subject to Codee requirements. The committee will have several functions. It will respond to Board of Commissioners assignments. In addition, the committee may conduct systematic reviews of the Code to identify and address existing ordinances which could be obsolete or do not reflect current safety, economic, or citizen needs. Committee Chair Hoyte Decker said, "This committee will be productive by evaluating matters of concern to the public. In order to do so, we want the support and participation of the public." The committee has set up a public email address, <u>rbloc@yahoo.com</u>, so citizens can submit their concerns, suggestions, and comments. Use the email to join a mailing list to be created to inform subscribers of upcoming meetings as well as report on results of committee actions taken. The committee's first meeting is scheduled for 9:00 AM, Friday, February 16, 2018, at City Hall. Committee meetings will be open to the public; input and participation are encouraged.
