### SMALL BUSINESS ADMINISTRATION - ECONOMIC INJURY DISASTER LOANS AVAILABLE IN DELAWARE

The U.S. Small Business Administration announces that federal Economic Injury Disaster Loans are available to small businesses, small agricultural cooperatives, small businesses engaged in aquaculture and most private nonprofit organizations located in Kent, New Castle/Sussex counties in **Delaware** as a result of excessive heat/drought from July 16-Sept. 29, 2015. "When the Secretary of Agriculture issues a disaster declaration to help farmers recover from damages and losses to crops, the SBA issues a declaration to eligible entities affected by the same disaster," said the director of SBA's Field Operations Center in Atlanta. Under this declaration, the SBA's Economic Injury Disaster Loan program is available to eligible farm-related/nonfarm-related entities that suffered financial losses as a direct result of this disaster. With the exception of aquaculture enterprises, SBA cannot provide disaster loans to agricultural producers, farmers or ranchers. However, nurseries are eligible to apply for economic injury disaster loans for losses caused by drought conditions. The loan amount can be up to \$2 million with interest rates of 2.625 % for private nonprofit organizations and 4 % for small businesses, with terms up to 30 years. These working capital loans may be used to pay fixed debts, payroll, accounts payable, and other bills that could have been paid had the disaster not occurred. The loans are not intended to replace lost sales or profits. Applicants may apply online using the Electronic Loan Application (ELA) via SBA's secure website at https://disasterloan.sba.gov/ela. Disaster loan information/application forms may also be obtained by calling the SBA's Customer Service Center at 800-659-2955 or by e-mailing disastercustomerservice@sba.gov. Loan applications can be downloaded from www.sba.gov/disaster. Completed applications should be mailed to: U.S. Small Business Admin., Processing/Disbursement Center, 14925 Kingsport Rd., Fort Worth, TX 76155. Completed loan applications must be returned to SBA no later than July 5, 2016.
