## FALL SIDEWALK SALES - OCTOBER 6-8

Rules and Regulations - City of Rehoboth Beach Merchants - No registration is required to participate in the annual Sidewalk Sales; however City of Rehoboth Beach merchants must observe the following rules & regulations: Sidewalk Sales are for City of Rehoboth Beach businesses that own, operate, and are licensed to do business at their respective storefronts. The Chamber and City are aware that vendors who do not own or operate a business with store frontage in the City of Rehoboth Beach have set up sale areas during the Sidewalk Sale time frames. The Rehoboth Beach enforcement officer has been made aware of the situation. Merchants located outside of the City of Rehoboth Beach are required to follow the regulations in their locality. All tables, chairs, etc. should be removed from the sidewalks by 9:00 PM; Licensed merchants shall set up in front of their business store front and sell their product only; The business entrance must be clear and open to public and pedestrian walkways must be open to public Tents are not permitted; Restaurants may set up and sell food directly in front of their business provided they adhere to all related Department of Health regulations. Unless state weather warnings/driving restrictions are issued, the event is rain or shine.
