CITY OF REHOBOTH BEACH REFRESHING PARKING SPACE LINES

On Monday and Tuesday of next week (April 8 and 9), the City will be refreshing the parking space lines on Rehoboth Avenue between the hours of 6:00 AM and 10:30 AM. The <u>median areas</u> will be coned off in sections, re-lined and cones removed – then cone off and move to next section of median, repeating the process up one side of the median and down the other. Once the median spaces are complete, the same process will take place up and down Rehoboth Avenue on the parking spaces facing sidewalks. The process is heat applied and not painted – allowing for fast application and immediate drying.

LEGISLATIVE UPDATE - HOUSE BILL#60 - INTRODUCED 3/21/13

Primary Sponsor: Hudson; Additional Sponsor(s): Rep. Miro & Sen. Bushweller Co-Sponsors: Reps. D. Short, Briggs King, Outten, Peterman; Sens. Hocker, Pettyjohn, Venables AN ACT TO AMEND TITLE 4 OF THE DELAWARE CODE RELATING TO ALCOHOLIC BEVERAGE CONTROL LICENSES AND TAXES, AND DIRECT PURCHASING AND SHIPMENT OF WINE. This bill would permit wine producers holding a valid license in this State or another state to obtain a license and ship wine directly to Delaware consumers so long as it is done through a common carrier with a "Carrier Permit". The bill requires the payment of taxes and obtaining the signature of a person 21 years of age or older before delivery of the wine.

HOUSE BILL #61 – INTRODUCED 3/21/13

Primary Sponsor: Miro; Additional Sponsor(s) Rep. Keeley & Sen. Venables; Co-Sponsors: Reps. D. Short, Hudson, Briggs King, Wilson, Kowalko, Potter, B. Short AN ACT TO AMEND TITLE 24 OF THE DELAWARE CODE RELATING TO PAWNBROKERS, SECOND HAND DEALERS, AND SCRAP METAL PROCESSORS AND PRECIOUS METALS, PRICING, AND WEIGHING. This bill sets certain standards for weighing and posting of pricing information relating to precious metals. This bill is modeled after laws in effect in Pennsylvania.
